Approve the hire of the Mayor's Administrative Assistant/Digital Content Specialist at \$38,00.00, effective May 13, 2026, upon passage of a drug screening, with an increase to Level 1/Step 1 at the end of the 90-day probationary period if applicable

Authorize the Contract with Discovery Christian for use of Field 1 at Eastside Park and authorize the Mayor to sign the same

Authorization to enter into a Memorandum of Understanding with the Rankin County School District for the Ranger Cadet Program for the 2026 - 2027 school year, and authorize Mayor to sign the same

Approve donations to Rankin County School System for Teacher Appreciation Week at Richland Upper and Lower Elementary School as requested pursuant to MS Code Ann. 21-19-49, and 17-3-1
